ABSTRACT

EDGAR RANGKASA; IMPLIMENTATION OF AUTONOMY REGIONAL POLICY MAKES COMMUNITY WELFARE (Study on the Implementation of Government Affairs on Education, Health, and Employment in Bekasi City). This dissertation under the guidance of Prof. Dr. Zudan Arif Fakurroh, S.H., M.H. as the Advisor and Prof. Dr. Faisal Santiago, SH. MM, as co-Advisor.

Implementation of regional autonomy government, its success depends very much on the good intentions of state organizers, bureaucratic apparatus at the central and regional levels to jointly maintain the unity of the Unitary State of the Republic of Indonesia and create the welfare of the people in a democratic way. Between state organizers, ie between the central government and local governments requires prior perception tapping on the content of regional autonomy that includes; Authority, assets, institutions, personnel, finance, representatives (DPRD) and public service management. In the implementation of policy to realize the welfare of society in the field of Education, Health and Employment, is not solely based on the power-sharing approach that tends to be interpreted sovereignty, but must be considered and understood through welfare approach for the people of the region and the better the implementation of government functions in Regions and in supporting the integrity and existence of the Unitary State of the Republic of Indonesia. Problems, 1. How Governance To Increase Community Welfare In Order Implementation of Regional Autonomy Local Government of Bekasi City? and 2. How Implimentation of Autonomy Policy of Local Government of Bekasi City, In Implementation In The Field Of Health, Education And Manpower To Realize People's Welfare In Bekasi City? This research methodology uses normative approach of research and social-legal research. In the normative study the study is based on the legitimacy of the law and its social-legal research approach on factual and implicit matters. The results of his research that the implementation of government in order to improve the welfare of the community in the context of the implementation of regional autonomy Local Government of Bekasi City is basically organized based on Law Number 23 Year 2014 on Regional Government. To realize the welfare, the Local Government of Bekasi City made a Regional Short Term Development Plan (RPJPD) called RPJPD Kota Bekasi Year 2005-2025 which then poured in Bekasi City Local Regulation No. 01 of 2011 on Amendment of Bekasi City Regulation No. 14 of 2008 On the Medium Term Development Plan of Bekasi Municipality Year 2008-2013. Implementation of the Regional Autonomy Policy of Bekasi Municipality, in the Implementation of Health, Education and Employment in the Realization of People's Welfare In Bekasi City, the City Government of Bekasi has implemented its policy based on legal legitimacy which is implemented through Bekasi City Regulation. While this is related to health, education and employment, not fully able to provide maximum service. It is suggested that intensive supervision should be accompanied by an evaluation of local regulations that are not feasible, so that services to achieve prosperity can be effective and efficient for the community. This requires dynamic legal regulation and reflects community justice.
