

## ABSTRACT

**EDY SUPRAYITNO; Title: "Use of Justice Collaborator as an Alternative in Combating Narcotics Organized Crime". This dissertation is under the guidance of Prof. Dr. H. Faisal Santiago, SH. MM, as Advisor and Dr. H. Azis Budianto, SH. MS as co. Advisor.**

Crime of organized narcotics crime is one type of transnational crime which is also called extraordinary crime. For this reason, law enforcement in the context of eradicating and uncovering drug crime networks, especially in the North Jakarta Tanjung Priok Port Police Station, the Narcotics Investigation Unit has made an effort to use justice collaborator as an alternative in its disclosure. The problems are; 1. Why can the concepts and benefits of using justice collaborator be an alternative effort in uncovering narcotics crimes in Indonesia? And 2. What is the form of legal protection against justice collaborator in an effort to combat narcotics crimes in Indonesia? Research methodology used in normative legal research or dogmatic legal research (dogmatic law research) or doctrinal research, and sociological jurisprudence research or empirical. The study was conducted with two approaches; normative juridical research, and sociological juridical research.

The results of his research on the use of justice collaborators can be used as an alternative effort in uncovering narcotics crimes in Indonesia, is a series of concepts empowering witness information as one of the evidence in the criminal justice system. Witness testimony Justice collaborators who are willing to be witnesses for the interests of disclosing Narcotics crimes by the Narcotics Investigation Unit in the jurisdiction of the Tanjung Priok Port of North Jakarta in 2017 are 4 (four) people and in 2018 there are 9 (nine) people, the total amount being 13 (thirteen people). Furthermore, from the 13 people, all of them were status as convicts sentenced to between 5 and 7 years. The Justice Collaborator that functions effectively is only 1 person, namely Nariyah, a narcotics convict who was sentenced to 5 years.

The testimony of Justice Collaborator Nariyah succeeded in uncovering 4 (four) Narcotics crime networks carried out through a process of law enforcement by the Tanjung Priok Port Police Satserse Narcotics North Jakarta. It can be concluded that the alternative concept of the use of Justice Collaborator can be used as a means for efforts to disclose Narcotics crimes, especially in the jurisdiction of the Tanjung Priok Port Police Station in North Jakarta. Implications of legal protection against the Justice Collaborator, will eliminate fear, as well as other legal certainty, he can get a reduction in penalties that are balanced with the risks carried out by the Justice Collaborators. The role carried out by Nariyah, is one manifestation of the community's legal awareness to be able to obtain a balanced sense of justice in the framework of participating in uncovering the circulation of narcotics abuse that law enforcement can do, in this case by the Narcotic Unit of the Port of Tanjung Priok Port, North Jakarta.
